- Active Individual Membership: Annual Dues \$125.00**  
Active members are usually the owner of a studio or photography business where a major part of the applicant's income is derived from photography. An owner must operate the business in Montana. Active members can be an employee of a photography business or vendor representative. This membership has full voting rights in MPPA. You may hold office after 24 consecutive months of continuous membership. There can be more than one active individual member from the same business so long as requirements are met. Active members are eligible for all official functions of MPPA including conventions, seminars, and the print competition are open to active members.
- Associate Individual Membership: Annual Dues \$98.00**  
Associate members are usually employees in the photography business or spouses. This could include out of state photographers, manufacturer's representatives, and processing lab personnel. Associate Members do not have voting rights and cannot hold office in MPPA. (Office eligibility requires 24 months of continuous active membership). Associate members are eligible for all official functions of MPPA including conventions, seminars, and the print competition in categories deemed appropriate in the print competition rules.
- Aspiring Membership: Annual Dues \$98.00**  
Aspiring Members are just entering the profession as a photographer; for first time members only. Aspiring membership will automatically be upgraded to Active Member in two years or if requested, after one year. Aspiring members do not have voting rights and cannot hold an office in MPPA. Aspiring Members are eligible for all official functions of MPPA including conventions, seminars, and the print competition in categories deemed appropriate in the print competition rules.
- Student Membership: Annual Dues \$98.00**  
Students attend approved schools in the photography field. The board of directors will be the deciding factor as to which schools will be approved. This membership will automatically upgrade to Active Member one year after the individual leaves school or at any time if requested. Student members do not have voting rights and cannot hold an office in MPPA. Student Members are eligible for all official functions of MPPA including conventions, seminars, and the print competition in categories deemed appropriate in the print competition rules are open to associate.
